EXTRACTS FROM THE CONSTITUTION OF THE REAL ESTATE BOARD OF NEW YORK, INC.

**Article II
Membership**

Section 6.

(c) Associate Membership: Attorneys, as individual practitioners, members of a partnership or professional corporation or those individuals designated as representative of their firms, partnership or professional corporation interested in the objects of the Board and not restricted to membership in any of the foregoing classes of membership may be elected to Associate Membership.

**Article IV
Fees and Dues**

Section 1.
