# EXTRACTS FROM THE CONSTITUTION OF THE REAL ESTATE BOARD OF NEW YORK, INC.

## Article II Membership

### Section 2.

**Commercial and Residential Brokerage Divisions:** Membership in the Commercial and Residential Brokerage Divisions shall be divided into classes as follows:

**(g) Salesperson:** Every salesperson in good standing, who holds a salespersons license pursuant to New York Real Property Law Article 12-A employed by a Broker A Member, whose application is endorsed by his employer or employing firm, shall apply for election as a Salesperson Member and if elected shall pay the dues prescribed for a Salesperson Member. In any case, the employing firm shall be responsible for the payment of the dues. If during the course of the year for which said dues have been paid the employment shall end, such employing firm, subject to the provisions hereof, shall be entitled to have a new salesperson employee elected to membership without payment of additional dues for the balance of such year.

## Article IV Fees and Dues

### Section 2. Dues

**Commercial Division:** The annual dues for members of the Commercial Brokerage Division shall be as follows:

Salesperson	\$400
Salesperson, 1st year	\$250

**Residential Division:** Members of the Residential Division's REBNY Listing Service (RLS) pay annual dues as follows:

	REBNY Dues	RLS Fee	Total Dues
Salesperson	\$275	\$125	\$400
Salesperson, 1st year	\$225	\$100	\$325

**Section 3.** The Annual Dues of all members shall be payable annually in advance on January 1st. Dues paid are not refundable.
